GUARANTEE AGREEMENT

CRISP ANALYTICAL LABORATORIES

_____ (hereinafter "Corporation") has applied for credit with Crisp Analytical Laboratories (hereinafter "Crisp") in order to make purchases on account. The person (or persons) executing this Guaranty Agreement (hereinafter "Guarantor") is associated with the Corporation in a business capacity such as a director, officer, stockholder, and/or employee. Guarantor has expressed an intention to personally guarantee payment of grant credit privileges to Corporation. For consideration, receipt of which is hereby acknowledged, the undersigned whether one or more, as a Guarantor, jointly and severally, hereby guarantee to Crisp that the debt owed by the Corporation to Crisp will be promptly paid when due on the following terms and conditions:

1. Payment for all purchases made by Corporation is guaranteed by Guarantor, without limit as to amount.
2. Guarantor agrees to pay all costs of collection incurred by Crisp, including but not limited to investigation costs, credit reports, attorney's fees, court costs, and if a judgment is rendered against Guarantor in connection with Corporation's account, Guarantor agrees to pay pre-judgment interest at the legal rate and post-judgment interest of 18% per annum.
3. Guarantor agrees to all terms of sales of Corporation, whether incorporated in a separate account agreement or otherwise.
4. If Corporation does not pay any debt owed to Crisp when it is due, each Guarantor who signs this agreement will be jointly and severally liable to pay to Crisp on demand, without further notice the amount due. The amount to be paid is to be paid to Crisp at its office in the city of Carrollton, Dallas County, Texas. Crisp shall not have to first file suit or exhaust its remedies against the Corporation before making demand on any Guarantor under this agreement.
5. Each person who signs this agreement agrees that Crisp can bring suit against him, jointly and severally, with the other Guarantors or against any one of the Guarantors and that Crisp can settle with one or more of the Guarantors who signed this agreement without settling with another; and that any settlement by one does not release another Guarantor from being liable under this agreement.
6. This Guaranty Agreement shall continue in full force and effect until such time Crisp receives written notification that an individual Guarantor desires to revoke his personal guaranty of debts of Corporations with Crisp. A notice of revocation by a Guarantor shall release only that Guarantor and no others. Each Guarantor shall remain liable for all debts incurred by the Corporation until acknowledge of receipt of said notification of revocation by Crisp.
7. Venue of all legal, administrative or other actions taken by Crisp to enforce any claims against Guarantor shall be in Dallas County, Texas. All amounts payable to Crisp by the Corporation are due and payable in Dallas County, Texas.
8. This Guaranty Agreement shall remain in effect, regardless of the incompetency of a Guarantor. If a Guarantor should die, the executor, or personal representative, heirs and assigns. The death or incompetency of one Guarantor shall not affect the liability of other Guarantors.
9. A settlement of any claim by Crisp with one Guarantor shall not release any other Guarantor. Crisp may sue Guarantor without having to join Corporation or any other Guarantor as a named party.
10. This individual Guarantor (s) each, by his signature hereby authorizes all credit references and all other credit information useful in the investigation of his credit history.
11. Guarantor agrees that venue of any lawsuit to enforce any obligation created herein is proper in Dallas County, Texas.
12. No notice of acceptance of this agreement shall be required.
